## Phishing: Don't Take the Bait

#### What is phishing?

Phishing refers to email messages that appear to come from a trusted company or individual. The fraudsters want you to click on a link or open an attachment that will compromise the information housed on your computer, including bank account and personal information.

Hackers are notorious for stealing your personal contacts and personal information and sending emails to your friends that appear to be from you. The fraudsters want to trick you into opening the email. Emails may be disguised to be from a friend or other trusted source to entice you to click on links or attachments. When you click on one of their disguised links or attachments, your computer can become infected.



#### What are the warning signs?

- Do you recognize the email address? Even if the answer is yes, you must still proceed with caution.
- Are there attachments? Do you normally receive attachments from this person or business?
- Does the file name look strange?
- Does the email request any personal information? Does it ask you to send credit card or account number information or log-in or password information?
- Are there grammatical or punctuation errors?
- Does the email seem generic or vague?
- Are there links? If so, check the link. Mouse over the URL and see if it looks suspicious.

#### When in doubt, find out!

A: Time is of the essence when reporting debit or credit card issues. For VISA Credit Cards, call our cardholder hotline at (800)325-3678 for assistance. Debit MasterCard issues can be reported via email at info@c-ocreditunion.com.This

mailbox is monitored by staff who can help protect your accounts. When sending an e-mail, include your full name, a callback number and *only* the last four digits of your card number. Additionally, you can call (304)781-0722 and leave a detailed voice mail about your situation. Again, only provide the last four digits of your card number.
